LOCATION OF THE ORGANIZATION

The " Subuddhipur Relief & Welfare Society for Backward community" is located, 25 Kms. south-east of Rajbhawan on the way of south-eastern rail-way from Sealdah (south) by any local train except Canning & Budge Budge local train and comedown at Baruipur Station. Other side anybody can reach to the organization by bus/private car through Kulpi Road via Garia (South Calcutta) nearby the same station, the time will take forty minuets & one hour respectively only. Then walking distance only, at the organization.

AREA OF OPERATION

The society is working in 4 numbers of Block under two districts (South 24 Parganas & New Jalpaiguri) through 22 associated youth Organizations. The beneficiaries under this society are completely resource poor and partly living under extreme below poverty line.
